Privacy & Cookie Policy Effective Date: March 1st, 2025

This Privacy and Cookie Policy ("Policy") describes how we collect, use, and share your information, the choices available to you regarding our use of your data, how we protect your information, and how you can contact us about our privacy practices. This Policy applies to any information collected when you visit or interact with our website (the "Site").

INFORMATION WE COLLECT Information You Provide We may collect personal information you provide directly, such as when you contact our support team via email. This may include your name, email address, telephone number, address, and any additional details you voluntarily share with us. We retain personal information only as long as necessary to fulfill the intended purpose or as required by applicable laws. Unless legally obligated to retain it longer, we will delete or anonymize your data once the retention period ends.

Automatically Collected Information When you access the Site, we automatically collect certain details using technologies such as cookies and server logs. Cookies are small data files stored on your device that enable the Site to recognize your device, remember preferences, track interactions, and identify referring websites. The automatically collected information may include:

- Browser type and settings
- IP address
- Device identifiers
- Operating system details
- Internet service provider details
- Language preferences
- Referring URLs
- Visit timestamps and duration
- Pages viewed
- Location data through GPS, geo-filtering, or other tracking technologies

Most web browsers accept cookies by default, but you can modify your browser settings to reject or remove cookies. Please note that disabling cookies may impact your experience on the Site and may affect certain opt-out mechanisms that rely on cookies to recognize your preferences.
